



## THE 2024 – 2025 PHYSICIAN ASSISTANTS GROUP DISABILITY INSURANCE PLAN SPONSORED BY THE AMERICAN MEDICAL ASSOCIATION (AMA)

FULL-TIME STUDENTS ENROLLED IN THE UNIVERSITY OF WASHINGTON  
MEDEX NORTHWEST PHYSICIAN ASSISTANT PROGRAM ARE ELIGIBLE FOR THIS COVERAGE

It's hard to imagine yourself as disabled. You're fit and healthy, right? But a surprising number of people do find themselves hurt or sick and unable to work or attend school – even if only for a short time. With student loan debt facing you, a disability could be financially devastating.

The AMA sponsored MedPlus Advantage (MPA) Long Term Disability Plan provides a monthly benefit in the event you become disabled and are unable to complete your training. The plan is designed to meet the particular needs and concerns of individuals who have chosen to dedicate themselves to the health care professions.

### Enrollment is convenient and easy!

The MPA plan is designed to meet the particular needs and concerns of individuals who have chosen to dedicate themselves to the health care professions. Here's how:

- If you become totally Disabled, you are eligible for a monthly base benefit of \$1,100.
- If Permanently and Totally Disabled, your eligible student loans, up to \$250,000 are eligible for repayment.
- If Permanently and Totally Disabled, you are eligible for a one-time \$5,000 lump sum benefit after 12 months of Permanent and Total Disability.
- Includes a Return to School/Work Benefit to cover expenses if disabled and participating in the Rehabilitation Plan.

This is your opportunity to enroll in this coverage without providing evidence of good health. Forms must be completed and submitted within 31 days of your first day in the University of Washington MEDEX Northwest Physician Assistant Program or during the annual open enrollment.

Enrollment outside of the annual open enrollment period will require Evidence of Insurability.

#### COST FOR THE PROGRAM

**Premium for this valuable program is only \$93.08 for the 2024-2025 year. That is \$1.79 per week - less than you'd pay for a latte at your local coffeehouse. The cost for year 2 (14 months) is \$108.59.**

#### ELIGIBILITY TO ENROLL

You are eligible to enroll in the Long Term Disability program if you are a full-time student in the Physician Assistant training program at the University of Washington.

#### ELIGIBILITY FOR BENEFITS

If you become totally disabled (as defined in the certificate of insurance), you will receive a monthly benefit starting on the first day after a 90 day waiting period. Your benefits will continue for the rest of your life or until your disability ends. Disabilities due to a Mental Health Disorder and Substance Abuse are limited to 24 months of Benefits.
